Background

There are 3 important policies for the Western Balkans launched in the last few years, namely Green Agenda for the Western Balkans, Comon Regional Market and the 6 billion EUR worth EU Growth Plan and Reform Agenda for the Western Balkans.

GREEN AGENDA FOR THE WESTERN BALKANS¹

Objectives

- Cleaning energy sources & protecting the climate
- Moving to a circular economy
- Depolluting air, water, and soil
- Building sustainable agriculture & food systems
- Protecting biodiversity and ecosystems

THE COMMON REGIONAL MARKET ACTION PLAN is made up of targeted actions in four key areas:

- Regional trade area: free movement of goods, services, capital and people, including crosscutting measures, such as the Green Lanes, to align with EU-compliant rules and standards and provide opportunities for companies and citizens;
- Regional investment area, to align investment policies with the EU standards and best international practices and promote the region to foreign investors;









¹ A New Growth Strategy for the Western Balkans, leaping from a traditional economic model to a sustainable economy, in line with the European Green Deal.

The main goal is to achieve carbon neutrality by 2050 and align with the European Green Deal's key elements.







- Regional digital area, to integrate the Western Balkans into the pan-European digital market; and
- Regional industrial and innovation area, to transform the industrial sectors, shape value chains they belong to, and prepare them for the realities of today and challenges of tomorrow.

EU GROWTH PLAN AND REFORM AGENDA FOR THE WESTERN BALKANS² based on four pillars:

- Enhancing economic integration of the region into the EU single market
- Boosting economic integration within the Western Balkans through the Common Regional Market
- Speeding up fundamental reforms
- Increasing financial assistance to support the reforms.

Why another Regional Conference?

"Center for regional economic research and analyses was established in order to monitor, analyze and implement the European integrative processes and build and strengthen the institutional capacities, aiming at faster integration of WB6 Region into EU, as well as to establish economic, scientific, educational and cultural cooperation within Balkans and with European cities and regions."

Together with all partners in this part of the South East Europe, Center for regional economic research and analyses is organizing Regional Conference promoting regional economic cooperation, focusing on practical, business oriented, monitoring of Regional Economic cooperation in Western Balkans, under the title *GROWTH 2024-2025*.

Economies of the Western Balkan are already closely linked to each other but also to the European Single Market. This has been made intensively clear in the recent years.
